VCAT approves supermarket proposal

Sad news: VCAT has approved the Lascorp proposal for a large supermarket and liquor store development at the old Gasworks site at 2 Duke St, Castlemaine. Our thanks go out to all those involved in the ultimately unsuccessful effort to preserve the integrity of this entrance to Castlemaine.

Change of State Minister for Planning

Richard Wynne retired from State Parliament at the November election. Over his time in the Bracks Labor government he held a number of Ministries - Housing, Local Government, Aboriginal Affairs and was Minister for Planning from the start of the Andrews Government until the recent November election. He is replaced by Sonya Kilkenny, who holds the portfolios of Planning and Outdoor Recreation.

UNESCO World Heritage bid for Central Victorian Goldfields

UNESCO World Heritage bid for the Central Victorian Goldfields is a partnership of 13 local governments and regional organisations, academia and the private sector, with the Honourable John Brumby and the Honourable Denis Napthine as patrons. Preliminary funding has been obtained to develop the bid. CASSOC supports the aims of the bid and is actively working to support Mount Alexander Shire's role in this. A Federal E.P.A established

Federally, Environment Minister Tanya Plibersek has established a new Environment Protection Agency which will have greater oversight of development proposals (see The Age, 9/12/22, p.5). The new legislation "... would include streamlining project assessment processes and improved regional planning processes to indicate where development could occur with minimum impact to the environment and to provide protection for threatened species, world heritage sites and ensure greater engagement with First Nations Peoples."
